In 2002, Judge White-Brown was appointed to the Los Angeles County Superior Court, where she served with distinction for more than 20 years across Family Law, Criminal, and Civil assignments, including in an Independent Calendar Court. As a trial judge, she presided over 300 jury and court trials, consistently demonstrating a meticulous and balanced approach to resolving complex legal matters.

Throughout her career, Judge White-Brown has been known for her deep understanding of the law and her ability to address complex legal issues with insight, diligence, and fairness. Her commitment to ensuring just and equitable outcomes has earned her the respect of colleagues, attorneys, and the broader legal community.
