Consumer claims including those brought under the Consumer Legal Remedies Act.
- **Employment:** Employment disputes including wrongful termination, wage and hour claims, discrimination and claims brought under the fair employment acts (FHAA and FEHA).

- **Insurance/Umpire:** Insurance disputes involving property loss, business interruption, first and third-party coverage, allocation of loss between carriers, primary-excess, and trigger issues/exhaustion of policy limits. Policies include construction, homeowner, professional errors and omissions, title, surety, auto and liability insurance.
- **Homeowner Association (HOA):** Claims between HOA and homeowner including breach of governing documents, board malfeasance, injunctive relief, and elections. HOA vendor and construction disputes.
